 - between 7am and 7pm Monday to Saturday; or
 - between 9am and 7pm on a Sunday or Public Holiday.
- 2. The equipment must not be used for more than: -
 - Two hours per day; or
 - One hour per day if it is a musical instrument
- 3. The specified equipment must be used in a reasonable manner and the noise emitted must not unreasonably interfere with the health, welfare, convenience, comfort or amenity of an occupier of a premise receiving the noise. Whether or not the noise emission unreasonably interferes is at the discretion of the authorised person.

"Specified Equipment" is any equipment, which requires the constant presence of an operator for normal use and includes many household items such as lawnmowers, power tools, basketballs and musical instruments.
