So that pupils continue to have a voice when they leave school, Danielle would like shire support to be able use PODD in parks and other shire facilities such as libraries, public toilets and the Aqua Centre. Danielle informed the Committee that the City of Bunbury are working on developing communication boards in all their playgrounds and suggested that the Shire of Manjimup liaise with the City of Bunbury to learn how they intend to go about this. discussed creating an action plan which starts with small steps with an ultimate goal for the Shire of Manjimup to be accredited for the Communication Access Symbol.
