10.5 Chief Bushfire Control Officer - Remo Pessotto

- It was all go at the opening of fire season in April, May with 12 fires getting out of hand.
- Private property owners lighting up heaps and bush, not knowing what the weather conditions were going to present together with strong winds and little rain, thus keeping brigade members and appliances on the go.
- Brigades also helping out Department of Biodiversity, Conservations & Attractions, Bridgetown Shire with pine fires and Manjimup FRS assisting on house fires, as back up water, if required.
- The shire were asked to assist with the Jarrahwood incident, being very busy with our own incidents we had to decline.
- The linking of radio repeaters 251, 292, 142, 293, 252, is an ongoing issue that needs to be sorted out.
- With weather currently presenting to date, it's a concerning indication of what will follow for this summer 2019/20. It's going to be very dry conditions, not looking good with what we will be faced but will deal with the best we can.
- Appreciation and thanks go to all volunteer brigade members for their commitment, assistance and support. Brilliant workmanship, thank you all.

10.6 DFES A/DO Manjimup - Steve Ward

• Event Debriefs

Have attended a number of post event debriefs held by the LG for events conducted in the Shire. These include the Targa SW and Truffle Kerfuffle. These have been useful to identify issues related to emergency response arrangements between DFES and Event Organisers. For example, a Road Crash at the Targa event highlighted gaps in communication arrangements and roles of DFES crews and contracted responders. This will be addressed for future events by closer communication and ensuring Risk Management Plans are sent direct to Stakeholders.

Walpole Response Capacity

The committee needs to be made aware that due to loss of volunteers in the VFRS and SES and low crew numbers that the capacity to respond to RCR or structural fires is likely to be compromised. DFES is working on strategies to address the shortfall by recruitment campaigns, individual training programmes or looking at other options such as day release prisoners from Pardelup.

10.7 DBCA Parks and Wildlife Services - Brad Barton

Prescribed Burning (Also see ATTACHEMENT 3 - Burn Program Map)

The Warren region completed its prescribed burn program in June 2019. Over 72,000ha of lands managed by DBCA across the Warren was treated during the 2018/19 year.

The burns were for a variety of purposes including town site protection, silviculture, biodiversity management and broad scale fuel reduction. Three notable burns include Gordon, Easter and completion of Dordagup mixed fuel burns directly adjacent to One Tree Bridge/Donnelly River valley and Quinninup respectively.

Planning for the upcoming 2019/20 annual burn program has been completed at regional level and is awaiting corporate endorsement.

Bushfire

The 2018/19 bushfire season was relatively mild. Staff and crews from Warren region assisted with bushfire events in Lewana, Jurien Bay, Esperance, USA, Queensland, Tasmania and Victoria.

Beach Emergency Numbers (BEN) Sign Program

The Shire of Manjimup is introducing the Beach Emergency Numbers (BEN) system to improve emergency response times by installing signs with unique numbers at beach access points. They are in the process of implementing approximately 140 signs along Shire of Manjimup beaches with public access. Hope to be in place by summer months.

Scenario

Thursday December 2019. Between 10am and 2pm

A fuel tanker carrying 35,000L of Avgas is refuelling at the fill station at the Manjimup Aerodrome. The driver is distracted and does not notice that a significant amount of fuel has been spilt. The driver tries to stop the fuel transfer immediately but is overcome by fumes and is incapacitated. The fuel runs towards the grated gully drainage system and into the interceptor tanks. These tanks overflow into Shire drainage system ending up in Bendotti's dam.

ARO is onsite and reports the accident to the appropriate authorities. (Calls 000, Air BP and Shire of Manjimup)

ARO advises Air Services that the airport needs to be shutdown.

RFDS are on the main apron awaiting patient transfer.

DBCA has a spotter plane in the air. Water Bombers are grounded.
