To be held this weekend, had a late Traffic amendment due to a large funeral in Pemberton, slightly moved their start line and timeframe for starting.

Discussion ensued, Andrew Campbell gave an overview on the importance of this information for all groups and liaising in the case of incidents occurring. Also, whilst not an event, Easter this year will have an influx of people which may impact all groups.

Paul Shields brought up an event not listed, Manjimup Motorcross State Rounds 4-5 April with a number of riders and supporters. Andrew clarified probably not classed as an event as not a purpose built dedicated facility, it only becomes an event when we have to put traffic management in place for spectators, but definitely good information for Health.

10.3 ST John Ambulance – Gary Willcox

- COVID lockdown caused them a number of issues, mainly with onwards shipments from Bunbury to Perth, having to do halfway meets to change over to avoid passes.
- Recruitment is a huge challenge they are so short of volunteers with Manjimup being the hardest area to recruit. There are contract negotiations between St John and WA Country Health but nothing confirmed regarding increased staffing.

Response from Report:

Todd Ridley: Asked if they have paraphernalia specific for Manjimup?

Gary Willcox: No, it is only generic.

Andrew Campbell: They are aware of the situation as the Shire has both Councillors and Staff who are volunteer Ambulance Officers. The biggest issue is patient transfers and the requirement of volunteers, where possible, to do transfers that is creating a fair bit of opposition. At a State level the government needs to get involved to sort something out, as from an employer's perspective, happy for employees attending priority calls but not 4 hourly transfers to Bunbury.

10.4 WAPOL - Isaac Rinauldo - Manjimup

- Generally quite good in town. Skate park only issue though they have held meetings at School with families involved, resolving the issues. Covering text messaging and bullying behaviour.
- Had five road crashes in four days, Manjimup has had no fatalities. One crash in Quinninup required airlift and a three car pileup at crossroads where roadworks held.

Response from Report:

Andrew Campbell: People towing caravans have no idea how to keep vans on road, particularly Walpole Road. Asked regarding welfare calls?

Isaac Rinauldo: Domestic Violence gone back up to pre COVID time.

Response from Report:

Andrew Campbell: COVID Vaccine, will this be done through Hospital?

Justine Kelly: Yes, Health Department, it will be a coordinated response, priority will MPS sites with Pemberton, Boyup, Nannup sites first with residents and staff, then filtering through to frontline staff. Need to be careful not to vaccinate all site staff in one day in case of reaction.

Gary Willcox: Advised he had his first COVID vaccine last week, he was okay though his arm hurt, didn't have temperature but had profuse sweating.

Andrew Campbell: DFES circulated information to Bushfire volunteers for registrations. Health has been working on establishing what is classed as 1B eg. Frontline and separate categories. Federal Government announced today where vaccines will be available, other than hospitals our closest is Bridgetown. Southern Forest and Manjimup Medical Centres have applied for this also. Shire of Manjimup submitted an expression of interest process to Department of Health in relation to establishing a mass vaccine centre and effectively providing a venue, offering the Town Hall, with this process closing on 26 March so await outcome.

- Todd read out Gavin Barke and Jeff Bennetts reports that were received in Correspondence.
- Application received this morning for NBN Fixed Satellite Service WiFi for welfare centres.
- Successful in receiving a Grant for four large firefighting water tanks 100,000 litres each that will be strategically located throughout the district at Brigade sheds.

EXECUTIVE SUMMARY

1. Overview

Emergency management exercises are an essential component of preparedness and should be used to enhance capability and contribute to continuous improvement¹. Hazard Management Agencies (HMA), Controlling Agencies (CA), Support Organisations and public authorities with roles and responsibilities under the State Emergency Management Framework (State EM Framework), District Emergency Management Committees (DEMCs) and local governments are required to develop and maintain capability-based exercises as their continuous 'business as usual' exercises program (State EM Plan 4.7.1).

Since 16 March 2020, a state of emergency for COVID-19 pandemic applies to the State of Western Australia, pursuant to section 56 of the Emergency Management Act 2005 (WA) (Act). COVID-19 remains a significant risk to the community and business continuity across all agencies, including the emergency management agencies.

The Exercise was designed to allow participants to connect remotely via video conference technology and work through the Incident Support Group (ISG) functions under simulated restrictions. The Exercise scenario was based on a significant bushfire event in the local government district.

2. Insights

- Exercise participants demonstrated a reasonable good understanding of ISG roles and responsibilities.
- ISG meeting agenda template requires a review.
- Exercise role players fulfilled the ISG responsibilities with minor assistance.
- ➤ Allowing 30 minutes of pre-exercise time to connect via Microsoft Teams (Teams) worked well for the Exercise participants.
- > The majority of the LEMC members were able to connect via Teams app and contribute actively to the exercise discussion.
- ➤ It is challenging to gauge non-verbal cues during a video conference, and there is a risk of misunderstanding due to a mismatch between the verbal and non-verbal cues.
- Exercise role players and participants were able to interact via audio-visual aids such as raise hand and comments built-in Teams function.
- Audio and video quality was generally good, and keeping the video option muted when not speaking improved the overall video conference experience.
- Remotely held ISG meetings via Teams video conference facility could save significant travel time and improve productivity/service delivery.

THE EXERCISE

3. Exercise Overview

Exercise Hermes allowed exercise participants to participate via Microsoft Teams video-conferencing application. Exercise Hermes is based on a hypothetical bushfire scenario. Exercise role players and participants stepped through the bushfire scenario under the guidance and mentoring of South West District Emergency Management Advisor, Department of Fire and Emergency Services. This methodology enabled HMA/Controlling Agency, and support agencies to collaborate remotely. Additionally, the ISG exercise highlighted any limitations or technical issues associated with remote video conferences.

4. Exercise Aim

Exercise Hermes aims to evaluate the effectiveness of ISG meetings via video teleconferencing facility.

5. Exercise Objectives

- > To familiarise the roles and responsibilities of ISG meetings.
- > To assess the ability of LEMC members to connect via Teams app video conference tool.
- ➤ To validate the sharing of critical incident information, i.e., bushfire map containing fire shape, agency reports.

6. Exercise Scope

The scope of the ISG Exercise is based on the <u>State Emergency Management Capability Framework</u>, 6.1 - Command, Control, and Coordination function. The ISG Exercise is seeking improvement with the pre-established protocols and structures that define the interrelationships between stakeholders during an emergency event and facilitate effective command, control, and coordination.

8. Exercise Format

Exercise Hermes was a Simulation Exercise (SIMEX) designed to allow LEMC members to experience and participate in the virtual ISG meeting. Each participant required access to a personal computer, laptop, or smart device (phone or tablet) equipped with internet access, microphone, and camera.

9. Exercise Scenario

The scenario for the Exercise is based on a bushfire incident east of the Pemberton townsite. A rapidly moving weather front caused extensive dry lightning strikes across the South West land division. Two separate fires were reported by the DBCA spotter plane in the state forest heading in a WSW direction under strong NE winds. Fire one was reported as 150 hectares and fire two 245 hectares, both uncontained and uncontrolled.





No of Permits Issued

• 2020 9th Nov to Dec 31st 84 Permits were issued out in the shire, and from the 15th March 2021 already 14 permits have been issued for land owners to burn.

Weather Conditions

 The four thunderstorm events that came through the area late December to early January only 5 strike on private properties most of the strike were on DPaW forest. This year have notice very strong persisting eastly, south East winds very drying conditions and high temp, then follow with steady but large amounts of rain through the shire putting the average of rain fall up for the start of the 2021.

Brigade Business / Issues

 A DEFS hired seasonal H/D was placed in Manjimup Shire, It has been placed out East of Manjimup in the Dunreath and Upper Warren Brigades to be shared between them, it was decided to be put out east of Manjimup to protect the Nyamup mill 26 mill homes, also Kin Kin resort has 13 chalets, there is a Shalem Health Retreat, and Tone River Cottages privately own with 26 homes.

- 1. Fire season has been relatively uneventful within the Region to date, with two Level 2 Beaufortia fire in Nannup (DBCA) and Level 2 Yallingup complex fires.
- 2. Supported Red Gully (Shire of Gingin) and Wooroloo fire in Perth with crews from the LSW over 7 days
- 3. DFES still have staff embedded into the State COVID 19 Incident Response Team and responding accordingly to Government directives.
- 4. We are planning a Leaders Forum for LSW BFB and VFRS officers to attend. Proposed month September 2021 at Donnelly Village (TBC).
- 5. Launch of Bush Fire Ready in Walpole 18 March 2021, 6pm at the Town Hall. We are recruiting volunteers to act as Facilitators and Street Coordinators in the area.
- 6. The Region has been working with the RFD and Local Governments on streamlining the Mitigation Activity Fund process and operating guidelines.
- 7. The Bushfire Centre of Excellence has officially opened in Nambeelup, and a training calendar published for Bush Fire specialist courses

QUARTERLY REPORT

3rd Quarter – 01st January to 31st March 2021

Meeting: Shire of Manjimup

Date: Wednesday 17th March 2021

- The Department has been activated for 2 bushfire events this quarter as follows:
 - Beaufortia Bushfire from 20th January 2021
 - Watch & Act was issued at 13:23 hrs;
 - We were contacted mid-afternoon by Louise Stokes from Shire of Nannup re a fire in the locality of Darradup, approximately 35 kilometres from Nannup. DBCA/Parks & Wildlife Service had contacted Louise re the fire and asked for an evacuation centre to be set up. Louise thought there would be about 6 residents who would present to register but would have alternative places to go. Louise indicated she would open the centre and contact us if the incident elevated. An ISG via Teams was held at 17:00 hrs with agencies; with the final ISG on Friday 22ndFeb but able to be reinstated if the event escalated. In all 12 people registered and some people camped on the Foreshore overnight by arrangement with the Acting Ranger.
 - All clear was issued on 24th January when the event was now contained and controlled. Cause of the fire was lightning.
 - Yallingup Bushfires for 6thFebruary 2021;
 - Emergency warning was issued at 19.02 hrs;
 - We were contacted by Vik Cheema at 18:58 hrs re a fast-moving, rural/urban interface bushfire threatening Yallingup townsite and Injidup. Later alerts were issued for Quedjinup, Yallingup and Naturaliste. It was anticipated roads would be closed and many people may be displaced. We arranged for the Geographe Leisure Centre (GLC) to be opened by the City's Facilities team and our staff arrived at the centre from 9.30pm, including with a trailer with bedding (6 staff). No affected persons came to the GLC and we were advised to close at 22:55 hrs.
 - Steady rain was received over the region from a low which travelled down the State;
 several severe weather warnings and DFES alerts were also received in relation to this event.
 - All clear was issued for Injidup on Sunday 7th February and later in the day for Quedjinup, Yallingup and Naturalise. Cause of the fire is suspicious/deliberately lit.
 - City of Busselton held a Community debrief on Saturday 13th February 2021 which was live streamed on facebook and available https://www.facebook.com/CityBusselton/videos/182044383709429. This was both informative and insightful as to how emergency events unroll, timeline, processes involved and decisions made.
- PPE kits update
 - State Government is arranging for a small PPE kit to be available at Local Governments in readiness for an emergency activation. The items are being provided by 2 suppliers.
 - As per my emails, I understand the 1st part of the PPE order has arrived at our Bunbury office; I'm still waiting on the 2nd order to arrive and will then arrange packing and delivery of 25 kits for the SW. Further update tba ...

DPIRD COVID19 Update

DPIRD continues to support wider State Emergency Management Arrangements across the State.

Biosecurity Incidents and Responses – Update

Queensland Fruit Fly (Qfly) - DPIRD continues to respond to Qfly operations within Coolbellup since Dec 2020. Eradication and surveillance activities will be managed in accordance with the National Fruit Fly Management Protocol.

Browsing Ant response has transition to a National program, DPIRD activities are focussed on surveillance to verify eradication across the State.

Red Imported Fire Ant (RIFA) response has transition to a National program, surveillance activities are focused on establishing 'Proof of Freedom' to prove the pest has been eradicated.

Ehrlichia canis (Ehrlichiosis) DPIRD is conducting surveillance for the disease and has conditions on dogs moving out of northern WA to reduce the risk of the disease spreading to southern WA.

Warren Health Service Report 24th February 2021 COVID-19

- Health facilities continue to receive PHEOC (Public Health Emergency Operations Centre) Bulletins as updates are required with testing criteria, fact sheets & other key information
- Local Emergency Operations Meetings (LEOC) stood down currently post state lockdown in February.
- Warren & Pemberton HS continue to swab approximately 10 potential COVID-19 people per week, including day 11 swabs for interstate arrivals all of whom have returned negative results.
- Restrictions on visitor numbers continues as per previous two visitor per patient at one time only (visiting hrs remain normal 8am-8pm).
- Elective surgery at WHS continues with specialist surgeons visiting site per usual schedules.
- All visitors entering MPS site have onus of providing proof of flu vaccination.
 There is a revised Public Health Act document with clauses for emergency personnel attendance at MPS sites permitting entry.
- Staff Fit for Work Screening Process remains in place.
- Visitors to health facilities now able to utilise SafeWA app to register

Warren Region Update for LEMC Thursday 17th March 2021

Prescribed Burning

The Warren Region commenced a total of 18 prescribed burns in Spring / Summer with 31,780 has completed with Donnelly completing approximately 14,000 ha and Frankland approximately 17,800 ha.

The autumn burn program has commenced, and we will liaising with a range of stakeholders throughout the burn season to ensure the program maintains a high degree of consultation and discussion to manage any sensitive values.

With recent rains the risk profile from prescribed burning has reduced so we are looking at a very productive and efficient burn season.

Bushfires

Relatively busy season across the region – 26 fires in Donnelly and 6 in Frankland. 16 fires of the total of 32 within Warren region were lightning caused.

The largest fire of 3230 hectares at Black point was deliberately lit. A 985-hectare fire east of Lake Jasper was caused by lightning.

Staff from across the region have assisted with bushfires across the state including Jurien Bay, Red Gully and more recently Wooroloo.

- □. ISG could be held in person or via Teams <u>regardless</u> of COVID restrictions.
- ☐. All ISG meetings held for recent fires within the Shire of Nannup were held via Teams, and we have received positive feedback from all agencies, including the local government.
- □. A dedicated Teams group has been established at the SW district level to coordinate incident support arrangements across all agencies, and we will be using Teams to activate ISG in the first instance.
- ☐. For the in-person ISG meetings, Teams will be made available where possible for agencies to dial-in. It saves travel and operations time.
