<u>Pemberton Police – Ross Bartley</u>

- Only two months in his current position at Pemberton very happy to get another post in the South West. He was last in SW in Margaret River about 10yrs ago and been through some major fires and incidents.
- They have a small team of three and looking at busy times over the next few months.

• Manjimup has had limited emergency management incidents to report on as luckily, they have only had to attend a few traffic crashes.

10.14 Water Corporation – Mel Robertson

- Thanks to DBCA for their recent assistance.
- Reroofed the Mottram Street Tank.
- Business as usual.
- No power, no water.
- There will be a water outage to patch a leak with hopefully minimal disturbance as being completed during midnight and 2am.
- Manjimup dam down 6% this year.
- Looking at increasing water licence and comms a challenge.

The above report was received verbally at the meeting.

10.15 Western Power - Colin Jones

- Currently upgrading all communication towers, refurbishing, new batteries etc.
- No big issues, they are looking at speeding up work on outage times.

The above report was received verbally at the meeting.

11. General Business

11.1 Telstra – Mobile Phone Towers & Backup Generators – Guest – Michael Heydon

- A verbal presentation was received providing an outline of co funding project under the STAND program for portable genset to be stationed at exchange that could be deployed, also battery backup on all towers and in the event of widespread outage they will deploy more. He explained that as towers are linked even if one has power, they may not have coverage. Unfortunately, funding didn't get approved.
- Starlink has been trialled recently by WA Police.
- In June 2024 they are closing the 3G network as end of life.
- There is a direct to handset via satellite trial with text, then later they will look at both voice and data.
- Informed that if you have an iphone 14 or 15 they have SMS to 000 functionality in an emergency when there is no coverage.
- Telstra Coverage Map nothing has changed with sites being turned off etc, factors in play could be illegal repeaters, increase in demand so you then may not have the capacity with more data being used as these can all affect signal so

mobiles should not be solely relied on and you need to have other systems in place.

Sharon Austin Department of Communities asked regarding the fall pendant medical alarms for elderly currently on the 3G Network?

Michael Heydon Telstra advised that they aren't the suppliers, though they are working with the manufacturers of the alarms who will then need to update their own customers regarding this.

Discussion ensued with various members advising regarding the coverage reducing from what they had five years ago.

Brad Wren DCBFCO advised after changing to mobile in Yanmah area, their coverage has drastically reduced over this period and from an emergency services point they are letting community down as no longer reliable.

Todd Ridley CESM advised where previously there was coverage west/north of Manjimup and Palgarup, it has now disappeared. Since the new tower installed near Chip Mill in Diamond, residents who live directly near it had better coverage prior to the installation and since new towers have been installed in the area, the bushfire radio network has also been affected.

Michael Heydon Telstra answered that nothing has changed or been turned off but they may have had fortuitous coverage previously on a fringe area of the map and now other factors may affect this like illegal repeaters, increase in demand therefore reduction in capacity etc. This shouldn't be relied on in emergency need other systems in place. The towers shouldn't cause issues with frequency bans with radios, technicians tested it with no issues found. On a positive, Pemberton now has 5G coverage.

The Committee thanked Michael for his attendance.

Jeff Bennett DBCA left the meeting at 2.20pm.

11.2 Department of Communities – Local Emergency Welfare Plan - LEWP - South West - Manjimup Office - Bridgetown Greenbushes, Manjimup – Sept 2023 – Tabled

- The LEWP document was tabled at the meeting and Sharon Austin advised that this will now require updating to *Local Emergency Relief and Support Plan (LERSP)* which will happen in due course.
- **Trailer Walpole** There is a new support trailer that will be stationed in Walpole that has available bedding for up to 50-60 and fully stocked with small incidentals for evacuees. This will be housed at DBCA depot in Walpole.

Todd Ridley CESM enquired as we have not received further information back from Roma what the arrangements are for deployment and accessing the trailer?

Sharon Austin advised once the trailer is delivered to Walpole they will confirm the process that they are currently working through with who can deploy it, access etc.

11.3 WALGA Emergency Management Survey 2023

The WALGA Emergency Management Survey for 2023 was completed and lodged on 29 November 2023, no copy was supplied on lodgement.

Erin Hutchins DEMA advised that she will follow up to see if can obtain a copy.

11.4 Water Cartage in Shire (Item without Notice)

Ben Rose CEO asked Mel Robertson from Water Corp for clarification/understanding on the Water Cartage arrangements and also from an emergency services perspective? Mel advised that Northcliffe and Quinninup are cartage sites. Depending on demands, which Quinninup seems to have an expediential increase at the moment so they will look at the draw on that so see if there is a reason.

In the event of a fire impacting the Northcliffe/Quinninup area the local emergency services are aware that we only have what is available in those tanks. Local water cartage suppliers are aware that Mottram St is the area of choice, as the Seven Day Road/South West Highway draw point can cause hammer if they open and close the valve too quickly which can cause bursts etc.

The Airport site, the draw from the tanks can sustain the service providers about two planes, two fill points for the choppers however if you need more than two, your service doesn't fill at the same rate as your drawing, so then you call your water carters in again. Water Corp are working with Airport and Local Shire on upgrading those services but can only go up to the meter, then there is the internal infrastructure that is being managed from Shire perspective.

 - 1 x Deliberately lit on the rail reserve.
 - 1 x Structural Chip Mill FRS were called in as breathing gear had to be used.
 - 17 Were from landowners cleaning and tidying up around their properties, this was well before permits started and reignitions from previous burns.
 - 1 x farmer lost his tractor and small square baler plus 15 bales of hay before the Walpole brigade rounded it up with DPaW, the grass was green but still burnt 1.5 ha.

Regulation Burning Times – Period we are in

- Restricted period started on the 9th Nov for Zone 8. Manjimup and Pemberton.
- Restriction period for Zone 6 started on 19th Nov for Walpole and Northcliffe

No of Permits Issued

• 35 permits have been issued up to this date.

Weather Conditions

Weather conditions at this stage is well in front from this time last year with higher temperatures, stronger south east winds have dried out fuels sooner and from the fire Behaviour that has happened around the area we are dealing with fires getting out of hand very quickly, which have shaken up landowners that ended up losing control their burns. Also, on the 28th Nov a thunder storm came through mainly out East of Manjimup with thunder and lighting, places ended up with between 3mm to 84mm of rain and hail out close to lake Muir, all strikes were mainly in DPaW Bush.

Brigade Business / Issues

 With the recent amalgamation of Linfarne with Ringbarkers BFB, this brings our number of Brigades down to eighteen.

Brigade Deployments

• With the lighting storm up the line ended up, Deployed Ringbarkers 2.4 with a crew member to head up to help out on the Dwellingup Fire and at Hyden.

Warren Region Update for Manjimup LEMC meeting Wednesday 13 December 2023

Prescribed Burning

Warren Region has completed approximately 26,000 hectares of prescribed burning this spring. This has been a combination of 15 prescribed burns. 9 in Donnelly District and 6 in Frankland District. Due to an early start to the season, we have made some good inroads into the burn options program.

Recently we have undertaken some karri burning which is 4-5 weeks in advance of an average year.

Whilst we are still working within the restricted burn period, we will be targeting some more karri burns prior to Christmas.

Bushfire

Crews and staff have been also busy being away on several occasions helping with bushfires in Serpentine, Perth and down at the FRNP.

Warren region has only experienced 9 small fires this season. The latest one was at the Lake Muir Nature Reserve caused from a lightning strike 4 days after the lightning event.

The water bombers for this fire season were based in Manjimup from 23 November 2023.

Current Situation and Enhancements:

- The Department of Communities' Emergency Relief and Support Directorate (ERS) has been proactively implementing various initiatives to strengthen our capacity and capability in handling emergencies.
- These efforts are a part of our comprehensive preparedness strategy across the state, ensuring readiness for the 2023-24 high threat season.

Funding and Resource Enhancement:

- In late 2022, the Department of Treasury sanctioned additional funding to bolster the resource capacity of the ERS to 36 full-time equivalents (FTE).
- Recruitment for these positions is now underway.
- The majority of these positions are expected to be operational by December 2023.

Response to Advanced High Threat Season:

- On 9 November 2023, the Department of Fire and Emergency Services (DFES) advised that the onset of the high threat bushfire season had been advanced from 1 December to 9 November 2023.
- In response, Communities has activated the summer Early Response Team (ERT) roster effective from November 9. This includes the integration of two additional ERT staff members per on-call team, enabling a more efficient response to state-wide activations.

Emergency Management Preparedness:

1. Operational Planning:

- Communities is actively seeking involvement from staff across the State to join the Emergency Activation Workforce, enhancing our capability during high threat periods.
- Emergency management responsibilities have been incorporated into the job descriptions of all Communities staff.

2. Equipment and Logistics:

- The ERS completed a state-wide audit of emergency management equipment, resulting in several improvements:
 - Standardization of the emergency vehicle fleet and emergency response equipment in vehicles and trailers.
 - Acquisition of four additional emergency relief and support response trailers, raising the total to 22 across the state.
 - Enhancement of emergency management reserve stock and establishment of additional regional storage locations with essential emergency equipment.

3. Evacuation Centre Audit:

- In collaboration with Local Governments and emergency management agencies,
 Communities is identifying and assessing suitable evacuation centres state-wide.
- We have enhanced our evacuation centre risk assessment process and commenced a state-wide audit of these centres for better-informed risk assessment during emergency incidents.

4. Exercises, Training, and Partner Engagement:

- ERS has been conducting Evacuation Centre Training and Desktop Exercises across the state, focusing on effective response and support during regional emergency events.
- In October 2023, we facilitated a Desktop Exercise with 27 partner organisations to test how Communities could work in a coordinated way with State and Local partner agencies to respond to the needs of impacted people and communities in the response and recovery phases of an emergency.
- ERS also supported the DFES Dunsborough and Surrounds Community
 Preparedness Roadshow, delivering Person-Centred Emergency Preparedness
 workshops targeted to community sector partners and people with complex needs.

5. State Support Plan:

- Following the State Emergency Management Policy, a statutory five-year review of the State Support Plan has been completed.
- Based on feedback received, the plan has been renamed to 'State Support Plan Emergency Relief and Support'.
- The State EM Policy Branch at DFES has updated the State EM Framework documents, including revisions to welfare references and other consequential amendments.
- Local Emergency Relief and Support Plans (formerly Local Emergency Welfare Plans) are being updated to reflect the new terminology.

6. Capability Audit:

 Communities commissioned Nous Group to conduct an audit to establish the baseline capability of the Emergency Relief and Support sector in WA, with a view to identifying critical capability gaps across the state.

7. Lessons Learned:

 Following the Kimberley Floods, Communities has embarked on a Lessons Learned project. This initiative is vital for enhancing our operational accountability, continuous improvement, and strengthening our systems for future responses.





Shire of Manjimup LEMC DFES Report – 13 December 2023

DFES has been working with Telstra at a state level to address the concerns over mobile phone reception in the Region. Information received by DFES is attached to this report.

DFES attended the commissioning of the new Marine Rescue vessel which was carried out in conjunction with the annual Emergency Services Blessing of the Fleet in early December in Walpole.

Operations

VFRS Brigades across the Shire have been kept busy with various incidents since the last LEMC, with road crashes being a prominent feature. The commencement of the bush fire season has been challenging for the state, with the LSW Region being called on to support incidents in the Kimberley/ Pilbara, Goldfields and NSW.

Training and Exercises

The DFES Lower South West Region has been actively preparing for the bush fire season, undertaking training and exercising for staff and volunteers, together with reviewing response plans and agreements.







Prevention/mitigation activities:

DPIRD undertakes prevention/mitigation strategies in line with its role as the hazard management agency for animal and plant biosecurity.

Surveillance program to protect the WA bee industry

Western Australia has strong biosecurity and surveillance measures in place to protect the State's bee industry from exotic pests and diseases including the bee parasite, varroa mite.

Varroa mite was first detected in the Port of Newcastle in New South Wales in June 2022. The national eradication response is now moving to a management phase after it was deemed no longer technically feasible to eradicate.

WA undertakes State and national bee pest surveillance programs which include extensive surveillance at ports and airports, considered to be the highest risk entry points for bees and bee parasites.

The surveillance program is coordinated by the Department of Primary Industries and Regional Development (DPIRD) in WA with the support of volunteer beekeepers and covers Fremantle, Kwinana, Perth Airport, Bunbury, Albany, Esperance, Geraldton and Derby.

As part of the program, there are 40 sentinel hives in place at key locations across the State which act as an early warning system to detect exotic bees and signs of bee parasites. There are also 34 catch boxes located across Bunbury, Fremantle and Geraldton. Plans are underway to expand the sentinel hive program to monitor additional industrial areas and freight hubs across the Perth metropolitan area.

Floral sweeps using butterfly nets to capture bees for identification are also routinely undertaken at Fremantle, Bunbury and Geraldton ports to monitor for exotic bees and mites.

WA has strict border quarantine to reduce the risk of varroa mite and other bee pests and disease entering the State. Bees, bee products including honey and other apiary products and beekeeping equipment are not permitted to be brought in without meeting import conditions and or treatments.

It is also a legal requirement for all beekeepers including hobbyists in WA to be registered with DPIRD. This is vitally important so that they can be contacted quickly in the case of pest or disease detection.

Beekeepers are also encouraged to check their own hives regularly and report anything unusual immediately by calling the Exotic Plant Pest hotline 1800 084 881

DPIRD responses

Declared incidents which DPIRD is managing:

- Eight (8) declared level 1 and 2 incidents in relation to plant pests/diseases and aquatic pests/diseases
- Nil animal pest/disease incidents

Red dwarf honey bee

DPIRD is investigating the detection of the exotic pest red dwarf honey bee (*Apis florea*) discovered on the Burrup Peninsula near Karratha. Red dwarf honey bees are known to be a vector for numerous exotic bee pests, including brood diseases, internal and external mites, and bee viruses.

The department is calling on the State's beekeepers and land managers to monitor their area for any unusual bees or nests.

Quarantine Area

A <u>Quarantine Area</u> (QA) has been declared for the Burrup Peninsula in the Pilbara to support a biosecurity response to eradicate Red dwarf honey bee. Bee keepers with hives, equipment or those who have collected swarms on the peninsula are not permitted to move them outside the Quarantine Area to prevent the pest from spreading.

Affected bee keepers are asked to contact DPIRD's Pest and Disease Information Service (PaDIS) to advise of hives in the area. Workers, residents, businesses and visitors to the Quarantine Area are required to report observations of unusual bees to the PaDIS hotline or via the department's **MyPestGuide® Reporter** app to support surveillance

Impact

Red dwarf honey bees are social bees which live in colonies of at least 3,000 insects. They migrate, swarm, and abscond readily, making them a major threat for exotic incursions and to the Australian environment.

One of the major risks for Australia is that red dwarf honey bee (*Apis florea*) is host to a range of bee brood diseases, parasites, and viruses that may impact European honey bees.

The red dwarf honey bee can carry Euvarroa mite (*Euvarroa sinhai*) a close relatives to the destructive Varroa mites. The species can also carry Tropilaelaps mites (*Tropilaelaps clareae*) which is a known pest of European honey bees.

Red dwarf honey bees may also compete with other bees for floral resources.

What to look for:

Red dwarf honey bees are characterised by their external nesting habits. Their nest is made up of an exposed single horizontal comb less than 25 centimetres wide that is built around and attached to tree branches or other support, including buildings and shipping containers.

The pest is easily distinguished from European honey bees by their small size in comparison to the European honey bee, being just 7-10 millimeters in length. They have a red/brown abdomen with black and white bands

Look for unusual bees that look smaller than European honey bees or colonies with exposed combs.

Queensland fruit fly

Strict requirements for moving of fruit and fruiting vegetables in Bayswater and Belmont have now been lifted, with residents now subject to the same movement conditions as those in the broader Quarantine Area.

Residents are encouraged to continue good garden and waste disposal hygiene to help prevent future outbreaks of this significant pest, which could devastate the State's fruit and vegetable industries.

The Quarantine Area continues to be in place and includes Perth, Belmont, Gosnells, Kalamunda, Vincent, Joondalup, Swan, Wanneroo, Melville, Canning, Bayswater, South Perth, Subiaco, Stirling, Nedlands, Bassendean, Belmont, Claremont, Victoria Park, Cambridge and Mundaring.

While Bayswater and Belmont residents are no longer required to cook, freeze, process or solarise host fruit or fruiting vegetables before disposal, these measures are still highly recommended to prevent this or other pests taking hold in the area. Similarly, these residents do not have to remove fallen fruit every three days but are encouraged to do so to maintain good garden hygiene. Requirements for commercial horticulture businesses in the Quarantine Area remain and DPIRD officers continue to liaise with growers and provide assistance where required.

The new Quarantine Area Notice is in place until Tuesday, 5 December 2023 and will be reviewed as the biosecurity response progresses. The community is encouraged to remain vigilant to support the biosecurity response.

Response

The biosecurity response has made good progress and the program is being modified to the next phase of the campaign.

- · Baiting and property inspections have ceased
- Monitoring and surveillance is to continue

Polyphagous shot-hole borer – no update since last report

Polyphagous shot-hole borer (PSHB) *Euwallacea fornicatus* is a beetle native to Southeast Asia. The beetle attacks a wide range of plants by tunnelling into trunks, stems and branches.

DPIRD continues to respond to the confirmed detections of an exotic beetle Polyphagous Shot-Hole Borer in the Perth metropolitan area.

Response activities include:

- Conducting surveillance to determine the distribution of PSHB
- Containing the pest to prevent further spread to non-infested regions within Western Australia
- Providing advice and information to residents, industry and other stakeholders
- Ensuring that all response activities are conducted safely, consistently and efficiently

To stop the spread, a Quarantine Area Notice (QAN) is in place to support the Department of Primary Industries and Regional Development's ongoing surveillance program to determine the spread of the pest.

The Quarantine Area covers 25 local government areas. The new areas added to the expanded QAN on 21 March 2023 are:

- Beckenham, Canning Vale, Huntingdale, Kenwick, Langford, Maddington and Thornlie in the City of Gosnells
- Duncraig, Greenwood, Marmion, Sorrento and Warwick in the City of Joondalup
- Alexander Heights, Girrawheen, Koondoola and Marangaroo in the City of Wanneroo
- Ballajura, Beechboro, Bennett Springs, Dayton, Hazelmere, Kiara, Lockridge, Malaga, Middle Swan, Midland, Viveash, West Swan and Woodbridge in the City of Swan
- · Forrestfield, High Wycombe, Perth Airport and Wattle Grove in the City of Kalamunda

- enhancing EAD preparedness by focussed incident management training, emergency disease exercises and finalising policies and procedures for incident response.
- o enhancing communications with industry and community stakeholders to increase awareness of Emergency Animal Diseases and improve preparedness and likelihood of early disease detection and reporting.
- building and developing a veterinary reserve and enhancing veterinary student exposure to rural veterinary opportunities.
- o enhancing veterinary capacity
- enhancing the diagnostic laboratory capability and capacity by upgrading the laboratory information management system, including automation of tasks and enhanced sample tracking and security.

Severe Tropical Cyclone Seroja (Disaster Recovery Funding Arrangements WA - DRFAWA)

Incident details:

11 April 2021: Severe Tropical Cyclone Seroja crossed just south of Kalbarri around 8pm Australian Western Standard Time (AWST).

Impacts at Kalbarri and the nearby town of Northampton were severe with many buildings sustaining significant damage, mostly consisting of lost roofs but other structures were destroyed. Many locations recorded maximum wind gusts greater than 125km/h with the highest being 170km/h from Meanarra Tower near Kalbarri.

• The State Support Plan – Animal Welfare in Emergencies was formally activated on 9 January 2023 and remained activated until 3 May 2023 to provide support to the local government in relation to the coordination of animal welfare.

- Substantive Wheatbelt Development Commission CEO, Rob Cossart, has been appointed as the State Recovery Coordinator for the Kimberley floods.
- The State recovery structure, across the four recovery environments of Social, Economic, Built and Natural environment, has been formalised with appropriate State Government agencies leading the domains:
- Social: Department of Communities
- Economic: DPIRD
- · Built: Department of Treasury and Main Roads WA
- Natural environment: Department of Environmental and Regulation
 DPIRD has appointed liaison officers to sit on the social, built and natural environments State-level domains.
- The Shire of Derby West Kimberley has established its local recovery group and relevant subcommittees which are:
- Media
- Getting Home
- Cadjebut Airport
- Pastoral
- Social/Wellbeing

DPIRD has provided a departmental representative on the Shire of Derby West Kimberley's local recovery group and relevant subcommittees.

DPIRD has secured funding for an Industry Recovery Officer to be embedded with the Kimberley Pilbara Cattleman's Association (KPCA).

Disaster Recovery Funding Arrangements WA (DRFAWA):

Support measures are designed to assist in meeting the needs of primary producers whose assets or primary production business has/have been affected by a disaster for which DRFAWA has been invoked.

Category B - Assistance measures for primary producers may include grants for:

- Professional advice
- Reimbursement of fees (maximum \$1,500) to obtain professional advice directly related to addressing issues arising from the declared natural disaster event
- Freight subsidy (reimbursement)
 Primary producers can claim a maximum of 50% of the costs to the producer of transporting any of the following items as a direct result of a natural disaster:
- Livestock;
- · Fodder or water for livestock; or
- · Building or fencing equipment or machinery.
- Fencing (for livestock producers only)
 Primary producers can claim 100% of the costs associated with any of the following:
- restoration/replacement of fencing (to pre-disaster standard) where the fencing has been deliberately dismantled or damaged due to counter disaster operations activities undertaken in order to combat the eligible natural disaster event; and/or
- reimbursement of the costs of materials only (to pre-disaster standard) to repair/replace boundary fencing damaged/lost as a direct result of the eligible natural disaster event. The measure is only available where the fencing adjoins a major road/rail transport corridor and where the roaming of livestock may present a danger to the travelling public (i.e., the aim being to preserve public safety).

The applicant must demonstrate to DPIRD's satisfaction that, at the time of the natural disaster event, the property was being used to hold or agist livestock.

- Expression of interest for interest subsidy on a new loan to recover An interest rate subsidy may be available to primary producers for new loans:
- to repair/replace assets lost or damaged / repair damage caused by the natural disaster event
- for carry on purposes to implement the next season's production program
- or to replace livestock lost in the disaster for which the assistance measures under the DRFAWA have been activated

DPIRD's role in emergency management

DPIRD plays an important role in emergency management in Western Australia.

- Hazard Management Agency (HMA) for animal and plant biosecurity with responsibilities across prevention/mitigation, preparedness, response and recovery. Link to State Hazard Plan Animal and Plant Biosecurity: State Hazard Plan Animal and Plant Biosecurity (www.wa.gov.au)
- Provision of support to other HMAs by:

DPIRD Preparedness for the 2023-2024 Natural Hazards Heightened Threat Period

The Department of Primary Industries and Regional Development (DPIRD) has existing initiatives in place, and also undertakes additional activities, to assist in organisational preparedness for the natural hazards heightened threat period.

State Support Plan – Animal Welfare in Emergencies

The State Emergency Management Committee (SEMC) has formally assigned the role and responsibility for coordinating animal welfare in emergencies to the Department of Primary Industries and Regional Development.

The owner or person responsible for caring for an animal (the carer) is responsible for the welfare of that animal. The owner or carer's ability to address animal welfare issues may be hampered, or prevented, due to the nature of the emergency. In these circumstances, local arrangements, such as the local government's plan for animal welfare in emergencies (PAWE), may assist. If local arrangements do not exist, are inadequate or have been exhausted, the controlling agency or hazard management agency (HMA) may determine the need to access the arrangements under the State Support Plan.

The controlling agency or hazard management agency (HMA) may determine the need to activate the arrangements under the State Support Plan where:

- animal welfare is beyond the capacity and capability of the owners or carers, and
- any local or district arrangements are no longer sufficient or effective; or
- no local or district arrangements exists.

In addition, DPIRD may recommend activation of the State Support Plan to the Incident Controller.

Approval to activate the State Support Plan – Animal Welfare in Emergencies is by the DPIRD Executive Director - Biosecurity.

Note: DPIRD may support local arrangements for animal welfare prior to the activation of the State Support Plan through the provision of advice, communication and providing connection to animal welfare stakeholders or service providers.

DPIRD's responsibilities may include:

- liaise with the relevant controlling agency or HMA as a liaison officer and/ or member of the incident support group (ISG) or operational area support group (OASG);
- coordinates the activation of the DPIRD internal operational plan in line with this Plan:
- contribute to public information released during the emergency;
- provide situational reports to the CAWE on animal welfare in the emergency;

- establish the Animal Welfare in Emergences (AWEG) to consult on actions undertaken by DPIRD in coordinating animal welfare services for an emergency;
- liaise with the local government and other organisations to coordinate response activities including:
 - providing support and advice on transportation for evacuating animals;
 - identifying the availability of locations to house evacuated animals;
 - managing displaced or stray animals; assisting owners and carers to obtain Restricted Access Permits, where applicable;
 - assessing and triaging impacted animals;
 - identifying/administering treatment;
 - performing/assisting with transportation for euthanasia or perform on-site;
 advising on/arranging for disposal of deceased animals;
 - identifying/providing emergency food / water / shelter; and
 - identifying and reuniting animals with their owners or carers.
- Coordinate arrangements to best utilise volunteers and
- donations relevant to DPIRD animal categories;
- coordinate the reporting and future investigation of animal welfare complaints arising as a consequence of the emergency;
- liaise with and advise Local Government and other organisations about suitable temporary containment and other welfare needs of animals.

Business Continuity Plan

DPRID has a business continuity plan to assist in maintaining delivery of its critical functions.

DPIRD First Response Teams

DPIRD has first response teams (FRTs) to assist with a response in relation to its role as the HMA for animal and plant biosecurity incidents and emergencies, and its support responsibilities in relation to animal welfare in emergencies.

The DPIRD first response teams (FRTs) provide the Department with teams across the State, which may be activated to undertake required actions in relation to response and recovery.

Emergency management training

DPIRD has an ongoing schedule to deliver emergency management training and exercises.

The IEMB On Call Coordinator supports local DPIRD staff;

- by monitoring weather conditions, and incidents and emergencies across the state
- in their role on an Incident Support Group (ISG) or Operational Area Support Group (OASG);
- who undertake a role on a First Response Team.

Regionally based on call officers:

Regionally based on call officers fulfil this function from 25 December 2023 to 15 January 2024.

Regionally based officers:

- monitor weather conditions, and incidents and emergencies in their region
- are the Department's Liaison Officer on an ISG or OASG

DPIRD on call operates:

Monday to Sunday – 7am to 8pm

Warren Health Service LEMC Report 08th November 2023

COVID-19

- Warren Health Service has resumed a BAU "business as usual" approach in relation to management of Covid19 with outpatient & inpatient activity.
- Currently screening symptomatic patients via a RAT testing process.
- Inpatients with Covid continue to be nursed with full infection control precautions in place.
- Health service staff are still required to isolate from the workplace for 5 days if Covid positive & seek executive approval to return to the workplace as a close household contact.
- Staff have resumed wearing a face mask in the clinical setting and hospital visitors encouraged with mask wearing with the current covid / influenza trend in the community.

GENERAL

- Continues to be a sustained increase in patient presentations to hospital ED & admissions remain above average for the past quarter 2023.
- Hospital staffing continues to be closely monitored and covered with support
- Hospital has acquired a third rental property in Manjimup to support the required workforce. Currently housing dieticians, nursing, radiology staff & nursing students.
- Emergency procedures / drill discussion exercises have continued with a focus on fire and evacuation (code red & orange), bushfire (code yellow) and aggression management (code black).
